Property right

Scope of use

The scope of use of the chosen logo will be arranged between the supplier and the Brandman-agement-Team (GMM 2) at DB AG. Generally the use as reference in print- and online-media is comprised. The exact scope of use will be determined with the release certificate. To extend the scope of use the release certificate has to be adapted and renewed.

Licence fee

The usual licence fee for using one of our logos for purposes of reference amounts EUR 150,00.

Q1-supplier can use the logos free of charge by providing proof.

Term of contract

The licence agreement will be concluded for the period of one year. If needed, the agreement can be renewed by paying the licence fee again.
